Manufacturer's Certification Statement

On February 17th, the American Recovery and Reinvestment Act of 2009 became law. This bill extends and modifies the tax credits for windows, doors, and skylights established in the Energy Policy Act of 2005. This Bill includes tax credit incentives for homeowners to purchase energy efficient windows and doors. The following guidance is not intended as legal advice, and you should consult a tax professional with specific questions.

This legislation, commonly known as the Economic Stimulus Bill, includes a homeowner tax credit incentive of 30 percent of the cost of qualifying products, including energy efficient windows and doors to a maximum of \$1,500 per household for 2009 and 2010. Homeowners that previously claimed tax credits in 2006 or 2007 are eligible for the full \$1,500 limit.

The qualification guidelines include the following restrictions:

- 1) The tax credit for energy efficient windows and doors is only available for existing homes.
- 2) Windows purchased must have a U-Factor ≤ 0.30 and a Solar Heat Gain Coefficient of ≤ 0.30 .
- 3) Homeowners are required to maintain records that the windows meet the qualification requirements. These records are to include receipts and the Manufacturer Certification Statement. Taxpayers must keep a copy of the certification statement for their records, but do not have to submit a copy with their tax return.
